ORDINANCE NO. 21-03

**TO APPROVE THE GREEN TOWNSHIP - CITY OF CHEVIOT JOINT ECONOMIC DEVELOPMENT DISTRICT VII CONTRACT; AND TO DECLARE AN EMERGENCY.**

**WHEREAS**, on January 19, 2021, after publication of a notice of hearing in accordance with law, the City of Cheviot held a public hearing regarding the proposed Green Township - City of Cheviot Joint Economic Development District VII;

**WHEREAS**, the purpose of the public hearing was to inform the public of the proposed Joint Economic Development District, to describe its operation, to answer any questions that the public might have, and to solicit public comment; and

**WHEREAS**, after the hearing was conducted, the legislative authority of the City of Cheviot believes that entering into an agreement with Green Township for the Joint Economic Development District VII is in the best interest of the citizens of Cheviot;

**NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF CHEVIOT, STATE OF OHIO, TWO-THIRDS OF ALL MEMBERS THEREOF CONCURRING, THAT:**


Section 1. The Green Township - City of Cheviot Joint Economic Development District VII contract, a copy of which is attached hereto as Exhibit "A" and made a part hereof, is hereby approved by this Council.

Section 2. The Mayor is hereby authorized and directed to sign the agreement on behalf of the City of Cheviot.

Section 3. Upon passage of this ordinance, the Clerk of Council shall certify a copy of it to the Green Township Board of Trustees and to the Board of Hamilton County Commissioners.

Section 4. This ordinance shall be an emergency measure for the health, safety, and welfare of the citizens of Cheviot and shall take effect immediately. The emergency is necessary in order to allow the Green Township - City of Cheviot Joint Economic Development District VII to proceed without delay on the part of the City of Cheviot.






