TO AUTHORIZE THE SAFETY-SERVICE DIRECTOR TO SOLICIT BIDS FOR THE RECONSTRUCTION OF NORTH BEND ROAD, THE MUNICIPAL PARKING LOT ON NORTH BEND ROAD, AND ST. MARTIN'S PLACE.

WHEREAS, the Safety-Service Director has determined that the street of St. Martin's Place, between Robb Avenue and Darwin Avenue, is in need of reconstruction, and by Resolution 19-07 passed on March 19, 2019, this Council authorized the Safety-Service Director to solicit bids for reconstruction of the same; and

WHEREAS, the Safety-Service Director has determined that the street of North Bend Road, between Hilda and Woodbine, and the municipal parking lot on North Bend Road are in need of reconstruction, and by Resolution 19-17 passed on June 4, 2019, this Council authorized the Safety-Service Director to solicit bids for reconstruction of the same; and

WHEREAS, the expense for the reconstruction projects is expected to exceed \$50,000.00; and

WHEREAS, because of the expected expense, the reconstruction projects are subject to the competitive bidding requirements; and

WHEREAS, the Safety-Service Director has determined that it is in the best interest of the City to solicit combined bids for the projects for the reconstruction of North Bend Road and the municipal lot on North Bend Road and the reconstruction of St. Martin's Place.

NOW, THEREFORE BE IT RESOLVED BY THE COUNCIL OF THE CITY OF CHEVIOT, STATE OF OHIO THAT:

<u>Section 1.</u> The Safety-Service Director is authorized and directed to solicit bids for the reconstruction of portions of North Bend Road, the municipal parking lot on North Bend Road, and St. Martin's Place (between Robb and Darwin), according to the specifications on file in his office.

Section 2. Upon receipt of the bids, the Safety-Service Director shall present this Council with a summary of the bids received and his recommendation for the lowest and best bid.
