TO ACCEPT THE FIFTH AMENDED JOINT CHAPTER 11 PLAN OF REORGANIZATION OF PURDUE PHARMA L.P. AND ITS AFFILIATED DEBTORS (CLASS 4: NON-FEDERAL DOMESTIC GOVERNMENTAL CLAIMS).

WHEREAS, the City of Cheviot filed a proof of claim in Purdue Pharma L.P.'s Chapter 11 Bankruptcy Case for damages sustained by the City due to the opioid crisis; and

WHEREAS, the debtors have submitted a Fifth Amended Joint Chapter 11 Plan of Reorganization in the bankruptcy case, and the solicitation agent is soliciting votes from the holders of certain claims against the debtors, including the City; and

NOW, THEREFORE BE IT RESOLVED BY THE COUNCIL OF THE CITY OF CHEVIOT, STATE OF OHIO THAT:


Section 1. The City hereby accepts the Fifth Amended Joint Chapter 11 Plan of Reorganization in the Purdue Pharma bankruptcy case.


Section 2. The Law Director is hereby authorized and directed to submit the City's ballot on or before the deadline imposed by the bankruptcy court.


