RESOLUTION NO. 21-12

TO ACCEPT THE AMOUNTS AND RATES AS DETERMINED BY THE BUDGET COMMISSION; TO AUTHORIZE THE NECESSARY TAX LEVIES; TO CERTIFY THEM TO THE COUNTY AUDITOR; AND TO DECLARE AN EMERGENCY.

WHEREAS, the Council of the City of Cheviot met in regular session the 5th day of October, 2021, at the Cheviot City Hall with the following members present:

WHEREAS, on July 6, 2021, by Resolution 21-09, this Council adopted a tax budget for the next succeeding fiscal year commencing on January 1, 2022; and

WHEREAS, the Budget Commission of Hamilton County, Ohio, has certified its action thereon to this Council together with an estimate by the County Auditor of the rate of each tax necessary to be levied by this Council, and what part thereof is without, and what part is within, the ten mill limitation.

NOW, THEREFORE BE IT RESOLVED BY THE COUNCIL OF THE CITY OF CHEVIOT, STATE OF OHIO, TWO-THIRDS OF ALL MEMBERS THEREOF CONCURRING, THAT:

Section 1. The amounts and rates, as determined by the Budget Commission in its certification, are hereby approved and accepted.

Section 2. There is hereby levied on the tax duplicate of the City of Cheviot the rate of each tax necessary to be levied within and without the ten mill limitation, as specified in the following Schedule A and Schedule B:
