RESOLUTION NO. 19-25

TO AUTHORIZE THE SAFETY-SERVICE DIRECTOR TO ADVERTISE FOR BIDS FOR THE DISPOSAL OF SOLID WASTE; AND TO DECLARE AN EMERGENCY.

WHEREAS, the City's current contract for disposal of solid waste expires on December 31, 2019; and

WHEREAS, the cost of the disposal of solid waste is expected to exceed \$50,000.00, and therefore the City must comply with the statutory requirements for competitive bidding; and

WHEREAS, because the current contract for disposal of solid waste expires soon, the Safety-Service Director needs to immediately begin advertising and receiving bids for a new contract for disposal of solid waste.

NOW, THEREFORE BE IT RESOLVED BY THE COUNCIL OF THE CITY OF CHEVIOT, STATE OF OHIO THAT:

<u>Section 1.</u> The Safety-Service Director is authorized and directed to advertise for bids for the disposal of solid waste.

<u>Section 2.</u> The responsive bids shall be for a period of at least five years, and may include bids by volume (cubic yard), weight (ton), or both.

<u>Section 3.</u> Upon receipt of the bids, the Safety-Service Director shall present this Council with a summary of the bids received and his recommendation for the lowest and best bid.

<u>Section 4.</u> It is hereby found and determined that all formal actions of this Council concerning and relating to the passage of this Resolution have been taken at open meetings of this Council; and that the deliberations of this Council and its committees, resulting in such formal action, took place in meetings open to the public, in compliance with all statutory requirements, including the requirements of Section 121.22 of the Ohio Revised Code.

<u>Section 5.</u> This resolution shall be an emergency measure for the health, safety, and welfare of the citizens of Cheviot and shall take effect immediately. The emergency is necessary in order to ensure that the City is able to dispose of solid waste after the expiration of the current contract. This resolution shall take effect immediately.
