## **RESOLUTION NO. 23-07**

TO AUTHORIZE ADDITIONAL FUNDS FOR THE HARRISON AVENUE LPA FEDERAL ODOT-LET PROJECT; AND TO DECLARE AN EMERGENCY.

WHEREAS, the City entered into the LPA Federal Project Agreement with the Ohio Department of Transportation for the construction of a section of Harrison Avenue, which was authorized by Ordinance 22-27; and

WHEREAS, the City entered into an agreement with the Ohio Department of Transportation for the payment of said project, which was authorized by Ordinance 23-10; and

**WHEREAS,** pursuant to Resolution 23-01, the Safety-Service Director, via the Ohio Department of Transportation, advertised for bids for the project; and

WHEREAS, there was one bid received, which exceeded the anticipated amount; and

**WHEREAS,** to ensure that the City receives the funding from the federal government and ODOT, the City must commit to increasing its share, pursuant to the terms of the Agreement authorized by Ordinance 23-10 and

WHEREAS, it is in the City's best interest to authorize the release of the additional funds for this project to ensure its funding by the federal and state government.

NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE CITY OF CHEVIOT, STATE OF OHIO, TWO THIRDS OF ITS MEMBERS CONCURRING, THAT:

Section 1. The additional amount to of \$350,000.00 is hereby appropriated for the completion of the Harrison Avenue LPA Federal ODOT-LET Project

<u>Section 2</u>. The Safety-Service Director is authorized to take any action or execute any document necessary to commit the City to increasing its share by \$350,000 pursuant to the terms of the Agreement authorized by Ordinance 23-10.

Section 3. This resolution shall take effect immediately.
