Legislation:

Administrative Reports:

-Mayor Keller reports that the low bidder for the Grotto. Selby, Alex resurfacing project came in at \$170K. Camellia Court will be bid later with the Harding Avenue project. The City is hiring grass cutters. To date 120 properties have been written up for tall grass.

- -Safety Service Director Braun reports that Tangent, Grotto, Selby, Alex resurfacing project is underway. Public works is in the process of painting park stall lines. The new ambulance should be in service within the next week.
- -Law Director Kimberlee Rohr was not at the meeting and did not leave a report.

Other Business:

- -Mr. Smyth noted that the new Thai restaurant suffered a minor setback due to a roofing issue. They hope to be open by the end of June.
- -Ms. Hawk asked if there will be another grant opportunity for façade improvements. The answer is probably, but not at this time.
- -Mayor Keller stated that the transfer of the former Cappels building is still in the works. The law director is working on the contract for transfer of ownership.
- -Mr. Smyth reports that the Caravel Coffee Shop is now opening earlier.
- -Mr. Borgmann thanked Rich Martin for holding the dedication of the new flag pole. Also thanked FOE Aerie #2197 for the reception held following the dedication.
