RESOLUTION NO. 25-27

TO APPOINT SAFETY SERVICE DIRECTOR STEVE BRAUN TO THE BOARD OF DIRECTORS FOR CERTAIN JOINT ECONOMIC DEVELOPMENT DISTRICTS.

WHEREAS, the City of Cheviot has several Joint Economic Development Districts ("JEDD") in partnership with Green Township; and

WHEREAS, this Council previously appointed Councilman David Voss to represent the City on two JEDD Boards of Directors, and his current term on City Council expires December 31, 2025; and

WHEREAS, this Council needs to appoint a representative for the City on the Board of Directors for JEDD District V, for which Councilman Voss's current term expires on December 16, 2025; and

WHEREAS, this Council needs to appoint a representative for the City on the Board of Directors for Councilman Voss's unexpired term for JEDD District III, which will expire on August 1, 2026

WHEREAS, this Council has determined that the City of Cheviot should be represented on the Board of Directors for the above-mentioned JEDDs by Steve Braun.

NOW, THEREFORE BE IT RESOLVED BY THE COUNCIL OF THE CITY OF CHEVIOT, STATE OF OHIO, THAT:

Section 1. Steve Braun is hereby appointed to be the representative for the City of Cheviot on the Board of Directors for the JEDD District V UDF, effective December 16, 2025 (___ term).

Section 2. Steve Braun is hereby appointed to be the representative for the City of Cheviot on the Board of Directors for the JEDD District III Mercy Hospitals West, for Councilman David Voss's unexpired term effective today through the current expiration on August 1, 2026.

Section 3. Upon passage of this resolution, the Clerk of Council shall send copies to the Boards of Trustees for Green Township and Colerain Township.

Section 4. This resolution shall take effective immediately.
