ORDINANCE NO. 26-06

TO CREATE NEW FUND; TO ADD NEW LINE ITEMS; AND TO DECLARE AN EMERGENCY.

WHEREAS, the City has entered into a Joint Economic Development District contract with Green Township, Ohio, for the creation of Joint Economic Development District VIII for Coopers Hawk, and the City must create a new fund and new line items for the incoming funds, revenues, and expenditures.

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF CHEVIOT, STATE OF OHIO, TWO-THIRDS OF ALL MEMBERS THEREOF CONCURRING, THAT:

Section 1. A new fund is hereby established for the revenues and expenditures associated with the Joint Economic Development District VIII, and said fund shall be identified as JEDD VIII-Cooper's Hawk (Fund 713).

Section 2. The following line items are established:

- 713.025.6 – JEDD VIII- Cooper's Hawk Revenue
- 713.111.251.1 – JEDD VIII Cooper's Hawk Cheviot Share
- 713.111.251.2 – JEDD VIII Cooper's Hawk Green Township Share
- 713.111.262.1 – JEDD VIII Cooper's Hawk Long Term Maintenance
- 713.111.262.2 – JEDD VIII Cooper's Hawk Board of Directors
- 713.111.272.1 – JEDD VIII Cooper's Hawk 1% Escrow Fund
- 713.114.1 – JEDD VIII Cooper's Hawk Income Tax Revenue

Section 3. This ordinance shall be an emergency measure for the health, safety, and welfare of the citizens of Cheviot and shall take effect immediately. The emergency is necessary in order to allow the City to meet its financial obligations in a timely manner.


