ORDINANCE NO. 26-07

TO AUTHORIZE PAY RAISES FOR CERTAIN FULL-TIME EMPLOYEES.

WHEREAS, this Council has determined that it is necessary to increase the salaries for certain City employees.

WHEREAS, the current salaries for said City employees are as follows:

Safety-Service Director	\$129,891.33
Police Chief	\$119,486.17
Fire Chief	\$119,486.17
Public Works Superintendent	\$101,760.42
Assistant Auditor	\$ 54,169.73
Police/ Court Clerk	\$54,690.58
Deputy Tax Commissioner	\$54,690.58
Tax Specialist/Clerk	\$45,472.96
Office Manager	\$52,968.18

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF CHEVIOT, STATE OF OHIO THAT:


Section 1. Effective May 1, 2026, the Safety-Service Director, the Police Chief, the Fire Chief, the Public Works Superintendent, the Police/Court Clerk, the Office Manager, the Assistant Auditor, the Deputy Tax Commissioner, and the Tax Specialist shall have their salaries increased by 0% to 4%, which shall be at the discretion of the respective administrative official based on job performance.

Section 2. Effective May 1, 2027, the Safety-Service Director, the Police Chief, the Fire Chief, the Public Works Superintendent, the Police/Court Clerk, the Office Manager, the Assistant Auditor, the Deputy Tax Commissioner, and the Tax Specialist shall have their salaries increased by 0% to 4%, which shall be at the discretion of the respective administrative official based on job performance.

Section 3. The Mayor shall determine the raise, within the stated raise range, for the Safety-Service Director, Fire Chief, Police Chief, Police/Court Clerk, and Public Works Supervisor, and Office Manager.

Section 4. The Auditor shall determine the raise, within the stated raise range, for the Deputy Tax Commissioner, Tax Specialist/Clerk, and Assistant Auditor.

Section 5. This ordinance shall take effect at the earliest period allowed by law.
