RESOLUTION NO. 26-03

TO AUTHORIZE THE SAFETY-SERVICE DIRECTOR TO PURCHASE DUMP TRUCK.

WHEREAS, the Safety-Service Director has determined that the Public Works Department is in need of a new dump truck, consisting of a cab and chassis, dump bed, salt spreader, snowplow, and hydraulics; and

WHEREAS, the Safety-Service Director has determined that the estimated cost to purchase said dump truck is \$192,209.33 through the State's purchasing program, which is broken down as follows:

Cab and chassis: \$ 110,959.33 Blust Motor Service, Inc.
Dump bed, salt spreader, snowplow, and hydraulics: \$ 81,250.00 KE Rose Company

WHEREAS, this amount exceeds the Safety-Service Director's spending limit for which he can make purchases without approval from Council; and

WHEREAS, Council approves the Safety-Service Director's purchase of a new dump truck, consisting of a cab and chassis, dump bed, salt spreader, snowplow, and hydraulics, for \$192,209.33 through the State's purchasing program.


NOW, THEREFORE BE IT RESOLVED BY THE COUNCIL OF THE CITY OF CHEVIOT, STATE OF OHIO THAT:

Section 1. The Safety-Service Director is hereby authorized to purchase a new dump truck, consisting of a cab and chassis, dump bed, salt spreader, snowplow, and hydraulics, for an amount not to exceed \$192,209.33 through the State's purchasing program, which is broken down as follows:


Cab and chassis: \$ 110,959.33 Blust Motor Service, Inc.
Dump bed, salt spreader, snowplow, and hydraulics: \$ 81,250.00 KE Rose Company

Section 2. The Safety-Service Director is authorized to execute any documents necessary to effectuate this purchase.

Section 3. This resolution shall take effect immediately.
