

**CITY OF CHEVIOT

ORDINANCE NO. 26-10

TO AMEND THE 2026 ANNUAL BUDGET APPROPRIATIONS; TO TRANSFER CERTAIN FUNDS; CREATE A NEW LINE ITEM; AND TO DECLARE AN EMERGENCY.

WHEREAS, it has become necessary to make adjustments to the appropriations of the 2026 annual budget by increasing and decreasing certain budget line items, transferring certain funds, and creating a new line item related to JEDD VIII.

NOW THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF CHEVIOT, STATE OF OHIO, TWO-THIRDS OF ALL MEMBERS THEREOF, CONCURRING, THAT:

Section 1. The following budget line item shall be decreased as follows:

<u>Line Item</u>	<u>Decrease</u>
211.703.239.3	\$4,179.11

Section 2. The following budget line items shall be increased as follows:

<u>Line Item</u>	<u>Increase</u>
211.703.249.3	\$1,000.00
211.703.252.1	\$3,179.11

Section 3. The sum of \$100,000.00 shall be transferred from the General Fund (Fund No. 101) to Fire Equipment Fund (Fund No. 301).

Section 4. The sum of \$47,446.88 shall be transferred from the General Fund (Fund No. 101) to Energy Efficiency Fund (Fund No. 302).

Section 5. The sum of \$10,000.00 shall be transferred from the General Fund (Fund No. 101) to Pool Fund (Fund No. 502).

Section 6. The sum of \$30,000.00 shall be transferred from the General Fund (Fund No. 101) to Waste Collection Fund (Fund No. 503).

Section 7. The sum of \$300,000.00 shall be transferred from the General Fund (Fund No. 101) to Police and Fire Pension Fund (Fund No. 701).

Section 8. The following line item is established: 101.186.11 JEDD VIII COOPER'S HAWK CHEVIOT SHARE.

Section 9. This ordinance shall be an emergency measure for the health, safety, and welfare of the citizens of Cheviot and shall take effect immediately. The emergency is necessary in order to allow the City to meet its financial obligations in a timely manner.
